Internationalisation

Decom West Africa

- Technical Waste Services contacted by Petronas to look at West Africa (Mauritania) waste procedures, policies and capabilities. With a view of being in a position to tender for the Provision of Waste & NORM Management, Disposal and various support including RPS's, Packaging and Monitoring Equipment.
- Partnered with Local company and completed GAP analysis
- Meetings with Environment Minister
- Department for Nuclear
- Port Authority
- Completed RFI and started completing procedures, creating Waste Transfer Station, Educating staff and pre Tender preparations
- These included UK audits of potential partners

TECHNICAL WASTE



- After careful consideration of a number of possible partners TWS began in-depth discussions with Augean North Sea Services.
- This was partly due to the capabilities and location of the ANSS site in Dundee.
- The ability to handle material and complete decontamination within the port was very attractive and was considered lower risk than else where.
- The experience from the North Sea works give the UK a level of expertise not found elsewhere
- SEPA and the EA have permits and regulate the waste elements in such a way it gives other confidence in our abilities

South East Asia Region

- No experience in Decommissioning
- 30 Decommissioning projects already been referred to by Petronas in RFI's
- Assets from 1968 onwards.
- No real local capacity
- Will need experienced partners Lifts, Survey, Waste, Management and Planning
- P&A works due to start late this year with 2 3 projects per year starting 2020/2021
